

MWOB PARTICIPATION (DOLLARS IN MILLIONS)





WOMEN OWNED (WO) PARTICIPATION (DOLLARS IN MILLIONS)






MINORITY OWNED (MO) PARTICIPATION (DOLLARS IN MILLIONS)




MINORITY OWNED PARTICIPATION BY ETHNICITY (DOLLARS IN MILLIONS)




